The WUSHU & TAI CHI PRACTITIONERS ASSOCIATION Inc (formerly ANWTA) is a independent non-profit association having the principal purpose of furthering the standards of Wushu & Tai Chi in all States of Australia. The association was created by the cooperative efforts of an enthusiastic group of Wushu and Tai Chi schools having the common aim of such improved standards.

It was mainly through the efforts of Master Liu Deming that the sequence of events leading to the formation of the association occurred.

In 1999 Master Liu saw the need for regular competitions within the Wushu and Tai Chi communities and in that year organised the first National Wushu & Tai Chi Championships. Due to the success of this event it has become an annual competition of ever increasing standard and success. With the increasing number of schools involved in the competition a committee was formed to run the event each year. This committee formed the association with broadened aims and activities.

### **AIMS OF THE WTPA**

To encourage, promote, advance and develop the art of Wushu and Taijiquan in Australia;

To conduct, assist or participate in, and in general and to promote club, local, regional, national and international competition in Wushu and Taijiquan, and to improve the standards of Wushu and Taijiquan in Australia;

To make provision for and contribute towards prizes, certificates or awards to successful competitors in competitions conducted by the Association or those conducted by other organizations, as approved by the committee in a particular case;

To provide sponsorship to successful competitors in State or National competitions who, being members of the Association, are selected to represent their State in National competition, or to represent Australia in International competition;

To conduct, assist or participate in the conduct of, and in general to promote the conduct of workshops, seminars and meetings for the purpose of providing communication, sharing of knowledge, the training of practitioners of Wushu and Taijiquan, and training of officials and judges in Wushu and Taijiquan competitions;

To strive for governmental, commercial and public awareness and recognition of the Association in particular and the art of Wushu and Taijiquan in general;

To promote health and safety of members;

To link practitioners of Wushu and Taijiquan from various styles and traditions without precedence, whether as individuals or gathered in groups, clubs and organizations across Australia;

To network/liaise/affiliate with national and international organizations with the aim of broadening and strengthening the Australian Wushu and Taijiquan experience; and

Undertake and/or perform all such activities necessary, incidental or conducive to the advancement of these purposes.

### **BENEFITS.**

The *Control of Weapons Act 1990* (the Act) put in place offences for, among other things, the sale, advertising for sale, possession, use and carriage of prohibited weapons. Significant penalties apply to a breach of these provisions unless an exemption has been granted in accordance with the relevant provisions of the Act.

WTPA holds a class exemption in Victoria (subject to requirements of the Regulations) on behalf of members. WTPA members who are genuine participants in Taichi or Wushu Sword or Sabre shall have access to the exemption enabling the possession, use and carriage of such swords for the purpose of studying and participating in Wushu & Tai Chi. Participating includes receiving instruction in, practising, training, teaching and competing in the sport.

Wushu and Tai Chi players are already receiving the benefits conferred by the WTPA. Prizes have been awarded for competitors in organised competitions. Special workshops, for example for those who practice the range of competition forms in Wushu and Tai Chi are conducted, and for the future many other exciting events are in the pipeline.

Worthwhile discounts are available to members of WTPA for competitions, workshops and martial arts supplies. There is the regular newsletter, *Wushu News*, which keeps members up to date with developments in Wushu and Tai Chi throughout the world.
